

'THE JESUITS'

With the election in 2013 of **Jorge Mario Bergoglio** (The then Archbishop of Buenos Aires) as **Pope Francis**, the profile and reputation of 'The Society of Jesus', otherwise known as 'The Jesuits', has reached unprecedented heights. Over the centuries, since their founding, 'The Jesuits' have served very much as the '**STORMTROOPERS**' of the Roman Catholic religion.

I have borrowed this term '**STORMTROOPERS**' from its use in relation to German soldiers fighting in the First World War because of the similarity in tactics employed to achieve an aim. On this link <http://en.wikipedia.org/wiki/Stormtrooper> we read -

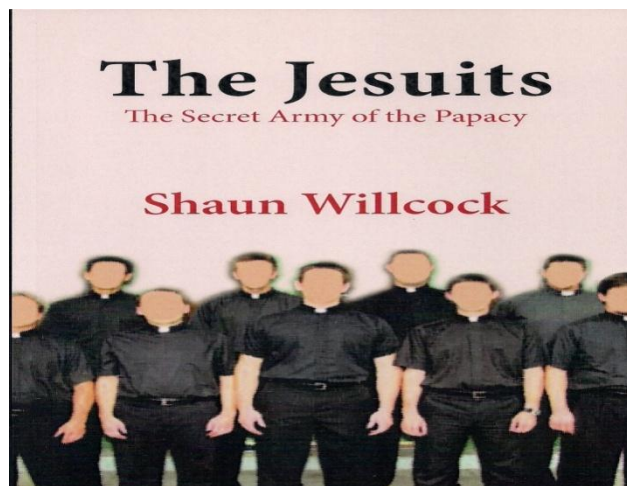
'**Stormtroopers** (in German *Sturmtruppen*; the term "thrust troops", *Stoßtruppen* was also used) were specialist soldiers of the German Army in World War 1. In the last years of the war, *Stoßtruppen* were trained to fight with "**infiltration tactics**"... The infiltration tactics of the **stormtroopers** are still in use today, in one form or another'.

On page 9 Shaun writes – ‘**The Jesuit Order, which has brought so much bloodshed and suffering upon the world, originated with a man named IGNATIUS de LOYOLA**’. On the back cover of Shaun’s booklet he wrote – ‘**History is filled with evidence of Jesuit intrigue, deception, duplicity, plots, murders and attempted murders etc. And against Protestantism, in particular, the Jesuits have always directed their energies by INFILTRATION of Protestant churches**.’” This is a time when so little is known of the Jesuits, and yet so much needs to be known. And this is the purpose of this book’.

As well as **INFILTRATION** I have also observed from first-hand experience that **INGRATIATION** has also been a **Jesuit tactic** and a Jesuit priest who has been very successful in this realm here in Northern Ireland is **PAUL SYMONDS SJ**. Just a few closing comments in the wake of that video –

1. **At 3:06 minutes on**, Cyril Cusack, in true Jesuitical style, made this statement that Loyola was ‘**one of the historical figures of the Reformation**’ – anyone listening and not overly familiar with Reformation times might think that Loyola should be viewed alongside and ‘in the camp’ of Luther, Calvin etc, who were those who rediscovered the truth of the Bible concerning salvation – a truth that had been hidden by and was utterly opposed to ‘the gospel’ of Roman Catholicism. The reality is that Loyola was an ‘**historical figure of the Reformation**’ in the sense that he founded his Jesuit Movement to counter and defeat the Protestant Reformation that, by the power of the Holy Spirit acting upon the Word of God, as found alone in the Bible, was by the Grace of God liberating people into Christ and out of their bondage to the ritualistic priest craft of Roman Catholicism.
2. **At 17:49 minutes on**, the ‘deceitful heart’ of Jesuitry is audibly quoted – something I made reference to in my own article on “**Calvin and Loyola**’ (link quoted above) when I wrote – “Let’s just look at a few excerpts from this, according to the pope, supposed ‘**gift to the entire Church**’ from ‘**the Spirit of the Lord**’, noting in particular the portion that I have highlighted in red. In *these* ‘**Spiritual Exercises**’ Loyola wrote ... **Thirteenth Rule. To be right in everything, we ought always to hold that the white which I see, is black, if the Hierarchical Church so decides it**”

3. **At 35:08 minutes on**, journalist and historian Paul Johnson, who was educated at the Jesuit Stonyhurst College, referred to those who were brutally executed during the reign of **'Bloody Mary'** as being **'Protestant extremists and militants'**. In stark contrast, **Bishop J C Ryle** in his book **'Five English Reformers'** wrote (pp7-8) as follows – **"It is a broad fact that during the last four years of Queen Mary's reign, no less than 288 persons were burnt at the stake for their adherence to the Protestant faith... It is a broad fact that these 288 sufferers were not put to death for any offence against property or person. They were not rebels against the Queen's authority, caught red-handed in arms**

(as had often been the case with many of those Roman Catholics put to death during the reign of Queen Elizabeth 1 but whom Rome refers to as 'martyrs' –a helpful short history of this period is located on <http://www.historytoday.com/marie-rowlands/english-catholics-reign-elizabeth> and whilst some Roman Catholics were 'martyred' for their faith many others were clearly executed for treasonous activity against Queen Elizabeth 1) .

They were not thieves, or murderers, or drunkards, or unbelievers, or men and women of immoral lives. On the contrary, they were, with barely an exception, some of the holiest, purest, and best Christians in England. And several of them the most learned men of their day".

4. **At 43:48 minutes**, reference is made, in relation to Loyola, to **'his conversion'**. This was no Holy Spirit, biblically-grounded **'conversion'** as I explained in my previous article on **'Calvin and Loyola'** when I wrote – **"Moving on I want now to address the claimed 'conversion experience' of Loyola that subsequently caused him to enter the Sorbonne to study Roman Catholic Theology. We can learn more about it on this web site <http://www.newadvent.org/cathen/07639c.htm>. There we read... One night as he lay awake, pondering these new lights, "he saw clearly", so says his autobiography, "the image of Our Lady with the Holy Child Jesus ", at whose sight for a notable time he felt a reassuring sweetness, which eventually left him with such a loathing of his past sins, and especially for those of the flesh, that every unclean imagination seemed blotted out from his soul, and never again was there the least consent to any carnal thought. His conversion was now complete. Is this a testimony to true (biblical) conversion? Credit for this 'conversion' is given to "the image of Our Lady with the Holy Child Jesus", the sight of which impacted greatly upon Loyola but we could ask which image had the greater impact on him – that of **Our Lady** or **Holy Child Jesus**? I would surmise that the former had the greater impact in view of the **reassuring sweetness** that he experienced. However this **'conversion'** seems to me to be false in the light of the teaching of scripture... **Hebrews 1:1-2** teaches that God no longer appears or communicates in **'divers manners'** as in times past such as **'dreams and visions'**. I believe that conversions since apostolic times come alone through **'preaching'** [see 1 Corinthians 1:21] combined with the regenerating work of God the Holy Spirit and this absolute **NECESSITY** of preaching in order for people to be saved is reinforced by Paul in **Romans 10:14-15**. The experience that Loyola and many other leading figures in Roman Catholicism have had would appear to have been an occultic, demonic and mystical delusion of a type that is common in non-Christian religions like Roman Catholicism, Mormonism, Hinduism Spiritualism etc. In his book **'The Great Reformation'**, R Tudur Jones wrote on page 244 **'Loyola was no stranger to mystical experiences but he was not alone in this. The combination of mysticism and practicality was an outstanding characteristic of Teresa of Avila (1515-82)... Such mysticism is held in high esteem in Roman Catholicism"**.**

In conclusion let me quote from **Shaun Willcock's** own '**CONCLUSION**' in his book '**The Jesuits: The Secret Army of the Papacy**'. Shaun wrote (page 48) –

'Christians must be aware of the bigger picture: that there *are* forces at work, under the direction of the evil "god of this world" (2 Corinthians 4:4) waging war against the Church of Christ and the true Gospel, that Romanism, "the *Mother of Harlots*" (Revelation 17:5) has always been the greatest enemy of the Church and the Gospel, and that the Jesuits are therefore at the very centre of Satan's purposes, for they truly rule over the Papal system. The evidence speaks for itself: let all Christians take heed'.
